



Export 2016 by country of destination





### KARLOVAC COUNTY - BASIC DATA




Karlovac County is situated in central Croatia and represents the connection between continental and coastal Croatia as well as the intersection connecting Europe and Adriatic Coast.

Economic profile is characterized by developed entrepreneurship where processing industry along with manufacture of food and beverages, fabricated metal products, machinery and equipment, rubber and plastic

products, wood processing and manufacture of textile are the main bearers of development. Trade and construction take very important place as well, along with significant cultural and natural resources for tourism development. Inside the export structure of the County manufacture of metal products and manufacture of machinery and equipment prevail, and the main export markets are EU and USA.

The County territory encompasses five towns (Duga Resa, Karlovac, Ogulin, Ozalj and Slunj), and seventeen municipalities (Barilović, Bosiljevo, Cetingrad, Draganić, Generalski Stol, Josipdol, Kamanje, Krnjak, Lasinja, Neretić, Plaški, Rakovica, Ribnik, Saborsko, Tounj, Vojnić and Žakanje). County area of 3.622 square kilometers has 128.899 inhabitants.

Karlovac County borders with two neighboring countries: The Republic of Slovenia and the Republic of Bosnia and Herzegovina, and four counties: Zagreb County, Sisak-Moslavina County, Primorie-Gorski Kotar County and Lika-Senj County.





Karlovac County area is not only the link between continental and coastal Croatia, but also the intersection of the most important roads linking Europe to Adriatic coast. One of the most important European corridors Vb goes through Karlovac County, and the County is also a part of middle-European traffic corridor Route 65.





Such position provides significant comparative advantage in doing business and investing, because the most significant business zones in Karlovac County are connected to modern highways and in average only approximately 95 kilometers away from Rijeka harbor, approximately 280 kilometers from Split harbor or 55 kilometers from Franjo Tuđman Airport.



Natural richness is presented by four beautiful rivers: Korana, Mrežnica, Kupa and Dobra. Bathing in clean waters, rowing, rafting and canoeing, hunting in forests from Draganić to Klek and Modruš, hiking paths and trails, bicycle tracks, caves and many other natural values of this area provides various opportunities of rest and recreation which is a good foundation for tourism development. Besides that, monuments



of historic architecture like numerous old towns and castles and valuable sacral buildings are especially interesting.



The town of Karlovac is administrative, economic and cultural center of the County. Known as the *Town on Four Rivers*, Karlovac is, due to its economic potential and the proximity of big cities Zagreb and Rijeka, a pleasant place for living and doing business. The town has been brought up in the 16<sup>th</sup> century as an ideal renaissance town in the shape of six-pointed star, which is visible even today. The construction of

the town began 13<sup>th</sup> of July 1579 with the purpose of defense of the Ottoman conquers, so consequently the birthday of the Town is being celebrated on that date. The name itself (Carlstadt) Karlovac has got in the honor of its founder, Austrian archduke Karl von Habsburg. (<a href="https://www.karlovac.hr">www.karlovac.hr</a>)

### THE ECONOMIC PROFILE OF KARLOVAC COUNTY

Even though Karlovac was originally designed as military center, it has become very soon economic center as well, due to its exceptional traffic and geographic location. In the 18<sup>th</sup> century and the most of 19<sup>th</sup> century, Karlovac was the most important trade town between Adriatic sea and Danube region. Along the shipping on Kupa river, roads were being constructed: Karolina road Karlovac – Rijeka, Jozefina



road Karlovac – Senj and Lujzijana road Karlovac – Rijeka. Due to construction of Budapest – Rijeka railway, Karlovac has lost the position of trade, reload and market center and has become the transit town. In the late 19<sup>th</sup> and early 20<sup>th</sup> century intensive development of crafts and industry has emerged in Karlovac and neighboring towns. This tradition has continued to these modern days.


Economic profile of Karlovac County today has been characterized by developed entrepreneurship especially the processing industry which is the main bearer of the development with wide specter of activities and products which quality has daily been proven in joint European and world market.



### THE STRUCTURE OF KARLOVAC COUNTY ECONOMY

Over 2.000 companies and 1.800 crafts are doing business in the area of Karlovac County.

The most significant economic branches are the processing industry, trade, construction industry and transport and storage, which provide 88% of overall revenue of the County economy.

The manufacturing industry is the main holder of technological development, export and employment. Its impact on County's economy is very well shown by the high share in the total Karlovac County revenue, i.e. 56,7%, which is significantly above the level of the Republic of Croatia (24%). Processing industry also comprises the half of total employees in the County.

High quality of job execution, according the schedule and professional staff in a way of use of the most contemporary equipment and material are the reason why construction companies hadn't really felt the crisis in construction sector in recent years. Just the opposite, they can commend themselves with exquisite references in construction of various works and buildings: geotechnical works, industrial facilities and hydroconstruction buildings, traffic infrastructure constructions, residential and business buildings and others not only in Croatian, but in the market of neighboring countries.




Trade has the highest number of registered companies in Karlovac County, and as well as the activity of transport and storage, its business successes also bases on exploitation of comparative advantage of position in the Republic of Croatia. Besides companies with its headquarters placed in the County, branch offices of foreign retailers represented in Croatia operate here as well.

Alongside mentioned activities, other service activities are not neglected as well. In fact, tourism and hospitality has increasing growth rates due to opening of new capacities and introducing new tourist products in accordance with the increase of continental tourist destination attractiveness for which Karlovac County has perfect preconditions considering its natural and cultural attractions.

### THE STRUCTURE OF MANUFACTURING INDUSTRY OF KARLOVAC COUNTY

The most important branches of manufacturing industry, according the generated total revenue, are the manufacture of food products and beverages, manufacture of fabricated metal products, manufacture of machinery and equipment, manufacture of rubber and plastic products, manufacture of wood and products of wood, manufacture of textiles and other.

The sector of food products manufacture includes production of meat and durable and semi-durable meat products; production of milk and dairy products; bakery products; production and processing of original Ogulin sour cabbage and other. When talking about manufacture of beverages, production of beer established in the middle 19<sup>th</sup> century, today led by well-known brands of Karlovac beer dominates. Karlovac County food products are qualified with the most significant quality marks, numerous domestic and international awards and successfully respond to aspirations and needs of consumers in croatian and european market as well.

Business subjects of metal processing industry and engineering in Karlovac County are focused on export, implementation of new technologies, professional staff education, quality system certification, ecologically acceptable production and connection to domestic and foreign manufacturers. Manufacturing program is diverse and can fulfill all of the needs of potential buyers and partners; from quality cutlery and dishes, various types of tool and machine tools, various types of machine processing, metal constructions, bands and bolts and all the way to production of diesel motors and equipment for energetics, special tools and equipment, steam, gas and water turbines, marine and industry pumps and hydro mechanical equipment or production of one of the most quality small arms in the world.

Companies which produce rubber and plastic products in Karlovac County are investing in modernization of technology process, expanding product assortments and export more and more products, but also attract foreign investors for partnership and further investment using its quality. Production program contains various types of plastic package, PVC joinery, production of bathroom and plumbing equipment, pool cover, processing of plastic masses by various techniques and other.

More than half of Karlovac County territory is covered in forest and wood land which provides excellent base for development of wood processing sector which has rich tradition in primary and final wood process. The sector comprises production of sawn timber, packaging, construction joinery, floor material, furniture and furniture parts and other.


Despite of dynamic challenges of the world market, textile industry in Karlovac County has maintained the position of significant exporter by its orientation on foreign markets and innovations in the production process, especially in production of various types of technic fabrics. On the other side, manufacturers of clothes are investing in shaping of new quality products as well, so recognizable fashion brands from Karlovac County companies exists on the market, especially in the field of underwear.

### LEADING EXPORT MARKETS



The most represented activities in the structure of export of County manufacturing industry are manufacture of fabricated metal products and manufacture of machinery and equipment with total share of 72%. It is followed by: industry of beverages, textile industry, manufacture of other non-metal mineral products, manufacture of food products, wood processing industry, manufacture of rubber and plastic products and other.

### **INVESTMENT PROMOTION AND BUSINESS BENEFITS**

### OUT OF THE ACT ON INVESTMENT PROMOTION

Act on investment promotion (OG 102/15) regulates granting of state aid to encourage investment.

Grants under this Act are related to investment projects and strengthen competitive capabilities in:

- manufacturing and processing activities
- Development and innovation activities
- Business support activities and
- High added value services

Investment, the initial investment, i.e. investment project is an initial investment for micro, small, medium and large enterprises into fixed assets entered in the property of the aid beneficiary:

- In the minimum amount of 50.000,00 euros equivalent to HRK together with creating at least three new jobs for micro entrepreneurs or
- In the minimum amount of 150.000,00 euros equivalent to HRK together with creating at least five new jobs associated with the investment project or
- In the minimum amount of 13.000.000,00 euros equivalent to HRK together with creating at least 10 new jobs for a university degree persons associated with the investment project.

**Major investment projects** are related to initial investment projects with eligible costs exceeding the amount of 50.000.000,00 euros equivalent to HRK, calculated at prices and exchange rate on the day of state aid allocation.

**Long term assets** encompasses tangible and intangible assets entered in the property of the grant beneficiary, expressed in the balance sheet of the grant beneficiary. Fixed assets must be in accordance to accounting standards and must be in function for the minimum of five years for large entrepreneurs, or three years for micro, small and medium entrepreneurs, i.e. for the entire time of incentives utilization.

**Grant beneficiary** is the entrepreneur – natural person (craftsman) who is income tax payer or a company, registered in the territory of the Republic of Croatia which uses grants, i.e. which has been granted by regional supports for initial investment and creation of new jobs, as well as supports for improvement related to investment.

**Grant for initial investment** is being calculated in a form of percentage of investment value, and is determined on the base of eligible investment costs.

The eligible investment costs are:

- Tangible assets (value of land/buildings and plant/machinery) and intangible assets (patent rights, licenses, know-how) or
- The cost of salaries for created jobs (gross salary for two year period)



**The amount of the grant** is calculated on the base of tangible and intangible assets or based on salary expenses for newly created jobs whereat higher amount is taken into consideration.

The sources of funding of the investment project must be provided in the minimum amount of 25% of eligible investment expenses by the grant beneficiary itself or from external funding and cannot contain any grant whatsoever.

The investment expenses excluded from calculation base:

- land.
- previously constructed buildings/constructions,

Application for authorization of status of grant beneficiary is submitted before initiation of works on the investment project, i.e. before the beginning of investment project.

The holder of incentive measures will be granted 100% of the incentive amount if the employment is related to:

- Unemployed person who has been registered in the unemployment register of the Croatian Employment Service for the minimum of three months, or
- person up to 25 years of age, without profession, assisted profession or vocational profession, first time employee, not registered in the unemployment register, or
- person up to 29 years of age, with high school or university degree, first time employee, not registered in the unemployment register of Croatian Employment Service, or
- person up to 29 years of age who is registered in the unemployment register of Croatian Employment Service within the period of 90 days of graduation day, the end of regular high school education or person without profession when ended elementary school, or
- person whose employment contract has been cancelled due to launch of insolvency proceeding.

If the employment procedure does not fulfill the conditions mentioned above, 40% of the amount of incentive will be granted.

### Incentive for labour intensive investment projects

Non-refundable financial aid from the table above (eligible costs of new jobs associated to the investment) will be increased for certain amount of percentage depending on the number of new jobs created for labour intensive investment projects.

The support for eligible expenditures of training associated to the investment project is granted according the regulations on state aid for training.



### Eligible expenditures are:

- trainers personnel costs, for the hours during which the trainers participate in the training,
- trainers' and trainees' operating costs directly related to the training project such
  as travel expenses, materials and supplies directly related to the project,
  depreciation of tools and equipment, to the extent that they are used exclusively
  for the training project; accommodation costs are excluded,
- costs of advisory services associated to the training project,
- trainees' personnel costs and general indirect costs (administrative costs, rent, overheads) for the hours during which the trainees participate in the training.

The aid intensity shall not exceed 50% of the eligible costs and it may be increased up to the maximum aid intensity of 70%:

- by 10% if the training is given to employees with disability and
- by 10% if the incentive is granted to medium sized entrepreneur and
- by 20% if the incentive is granted to small and micro sized entrepreneur.

## Incentives for development and innovation activities, business support activities and activities of high added value services

Extra incentives in a form of increase of incentive for the expenses of newly created jobs or non-refundable financial support for purchase of equipment/machines are granted for specific business activities shown in the table.

Activities of development and innovation focused on development of new ones and improvement of existing ones: products, production lines, production process, production technologies.

Activities of business support are carried out by: customer/user contact centers, detached business activity centers, logistics and distribution centers, centers for development of information and communication system and software.

Activities of providing high added value services include: creative services, catering and tourist services, management, consulting and educational services and services of industrial engineering.



### The incentives for capital expenditures of investment project

Non-refundable financial support can be granted for capital expenses of a minimum of 5 million euros valuable investment project and if minimum of 50 new jobs related to the investment project are created, within the period of 3 years after the end of construction.

Capital expenses for which non-refundable support is granted:

- costs of construction of new facility, industrial plant or catering and tourist facility
- costs of new machinery, i.e. production equipment purchase

The share of investment in machinery, i.e. production equipment must be the minimum of 40% out of total investment value, and the minimum of 50% out of purchased machinery, i.e. production equipment must be high technology equipment.

Incentives for investment of minimum amount of 13.000.000,00 euros equivalent in HRK with minimum 10 new jobs created for people with university degree associated to the investment project.

One or more of bellow mentioned incentives can be granted for start-up investment into tangible and intangible assets of newly established company in the minimum amount of 13.000.000,00 euros equivalent in HRK, with the minimum of 10 new jobs created for people with university degree related to the investment project. The Agreement on project preparation and implementation can also be concluded.

Incentives which can be granted based on the Agreement are:

- Incentives for insurance of fixed business conditions: co-financing up to the amount of subtraction of tax obligations and obligations based on contributions determined according to regulations valid at the time of submitting the application for authorization of grant beneficiary status according to the Act on investment promotion and tax obligations and obligations based on contributions according to regulations valid at the time of these obligations calculation, for the period of 10 years from the year of the beginning of the investment.
- Investment incentives: co-financing of the fragment of the amount of tax obligation of incentive beneficiary towards the State except Added Value Tax, i.e. fragment of the amount of contribution payment obligation for the period of 10 years from the year of the beginning of the investment.



- Incentives fifty fifty: co-financing up to 50% of revenue tax payment obligation, except Added Value Tax, for the period of three years from the beginning of the investment, without the interests.
- The grace period of tax obligations payment: loan for tax obligations payment, except Added Value Tax, for the period of three years from the beginning of the investment, without the interests.

### REGULATION ON INVESTMENT PROMOTION (OG 31/16)

The Regulation is applicable on entrepreneurs – natural persons (craftsmen), who are income tax payers or companies, registered in the territory of the Republic of Croatia, who intend to use investment incentive, according to the Law.

The Regulation prescribes:

- General terms
- Form and obligatory application content
- Procedure of application, granting and incentive use
- Obligatory content of annual report on investment project implementation and use of incentives

The application is submitted in forms prescribed by this Regulation.

Besides the Application following documents and data must be enclosed:

- Statement of the applicant on the registration in income tax system, i.e. on the obligation of income tax payment, in case when applicant is natural person craftsman

- Business plan for the period of five years, along with the projection of financial reports (balance sheet, profit and loss account),



- Valid construction permit, or other official document which approves construction, when constructions are built according the regulations which regulate space arrangement and construction,
- For constructions where construction permit is not being issued according the special regulation
  - a) for constructions that can be constructed without the construction permit, according the main project, the main project in PDF format
  - b) for constructions that can be constructed without the construction permit and the main project, technical description of planned works in PDF format.

The Applicant must submit other data necessary to evaluate application adequacy as well, at the request of the competent Ministry.

The Applicant submits the application to the Ministry under which jurisdiction the investment belongs according to the Law.

<u>The Ministry of Economy, Entrepreneurship and Crafts</u>, is amenable for micro, small and medium enterprises as well as large enterprises.

The examples of calculation of investment incentives can be performed by <u>incentives</u> <u>calculator</u> on the web page of <u>the Agency for investments and competitiveness</u> where <u>workflow of incentives application procedure</u> can also be found.

### OUT OF THE ACT ON AREAS OF SPECIAL STATE CONCERN

The Republic of Croatia has determined criteria under which the status of the area of special state concern is being assigned to local self-government units, towns, municipalities and settlements with war destruction consequences and difficulties of demographic and economic development.

The backwardness in economic, social, demographic and total development of areas of special state concern is the result of numerous factors and their complex interaction.

The first group are town and municipality areas that were occupied during the War on Independence and are located directly along the state border, and town or municipality center is no more than 15 km of airline far from the border and has no more than 5.000 residents according the Census from the 1991, as well as municipalities and towns of Croatian Danube region.

**The first group** in Karlovac County comprises town of Slunj and municipalities: Cetingrad, Rakovica and Vojnić.

**The second group are** areas of towns, municipalities and settlements which were occupied during the Independence war, and are not the part of the first group.

**The second group** in Karlovac County comprises municipalities: Barilovići, Josipdol, Krnjak, Lasinja, Plaški, Saborsko, Tounj.



**Settlements**: Banska Selnica, Banski Moravci, Blatnica Pokupska, Brezova Glava, Brežani, Brođani, Cerovac Vukmanički, Donja Trebinja, Donji Sjeničak, Gornja Trebinja, Gornji Sjeničak, Gornje Mekušje, Ivanković Sela, Ivošević Selo, Kablar, Kamensko, Klipino Brdo, Kljaić Brdo, Knez Gorica, Lipje, Manjerovići, Okić, Popović Brdo, Ribari, Sajevac, Skakavac, Slunjska Selnica, Slunjski Moravci, Turanj, Tušilović, Udbinja, Utinja, Vukmanić (Karlovac).

The outset in the definition of criteria for creation of system for determination of the underdeveloped areas were the criteria which are being applied in the European Union when implementing the structural policy of the Union.

**The third group** of the area of special state concern comprises municipalities that are rated as underdeveloped parts of Croatia according the procedure of evaluation based on three development criteria:

- 1.) the criteria of economic development refers to definition of areas underdeveloped in economy, and is measured by indicators: the income of residents, revenues of local self-government and other available indicators;
- 2.) the criteria of structural difficulties refers to definition of areas with distinct problems of unemployment, industrial and agricultural restructuring, and is measured by indicators: employment and unemployment, special indicators of development of industrial, urban and rural areas and other available indicators;
- 3.) the demographic criteria refers to definition of areas with especially adverse demographic indicators, and is evaluated/measured by indicators: population density, general population trend, vital index, age and education structure of the population and other available indicators.

Areas of special state concern in Karlovac County according the groups:

Based on the criteria of underdevelopment, the third group in Karlovac County comprises municipalities: Bosiljevo, Generalski Stol, Netretić, Ribnik.

(<u>Act on Areas of Special State Concern OG 86/08, 57/11, 51/13, 148/13, 76/14, 147/14, 18/15</u>)



#### **INCENTIVE MEASURES AND BENEFITS**

### **Profit taxing benefits**

Tax benefits and exemptions for tax payers who perform business activities in the area of special state concern

Tax payers who perform business activities in the area of Vukovar city according the special Regulation on reconstruction and development of Vukovar city and employ more than five employees for an indefinite period, whereat over 50% of employees reside in the aided area of local self government units classified as the first group according the level of development, i.e. in the area of Vukovar City, does not pay tax.

Tax payers who perform business activities in the area of local self government units classified as the first group according the level of development based on special Regulation on Regional Development of Republic of Croatia and who employ more than five employees for and indefinite period, whereat over 50% of employees reside in the aided area of local self government units classified as the first group according the level of development, i.e. in the area of Vukovar City, pay 50% of prescribed tax rate. The amount of exemption of profit tax payment is determined according the related regulations on de minimis aid.

Employment for an indefinite period is considered when employee has employment for an indefinite period at tax payer and has ones resident in te aided area of local self government unit classified as the first group according the level of development based on special Regulation on Regional Development of the Republic of Croatia, i.e. in the area of Vukovar city according the special Regulation on Reconstruction and Development of Vukovar city, for a minimum of nine month in the tax period.

The manner of implementation of tax relief is determined by the Ordinance adopted by the Minister of Finance in cooperation with the Minister amenable for regional development.

### Income taxing benefits

Benefits for the areas of special state concern and the area of city of Vukovar

Income tax payers who are self-employed by the terms out of Article 18 of Act on Income Tax in the area of local self-government units categorized within the first group according the level of development based on special Regulation on Regional Development of Republic of Croatia and in the area of Vukovar city determined on the bases of special Regulation on Vukovar city Renewal and Development, who employ more than two employees for an indefinite period and over 50% of those employees reside in the area of special state concern or city of Vukovar area are exempt from income tax payment obligation for business activities within those areas.

Income tax payers who are self-employed by the terms out of Article 18 of Act on Income Tax in the area of local self-government units categorized within the second group



according the level of development based on special Regulation on Regional Development of Republic of Croatia, who employ more than two employees for an indefinite period and over 50% of those employees reside in the area of special state concern or city of Vukovar area, income tax on those business activities on those areas is reduced by 50%.

The amount of income tax payment exemption is determined according valid de minimis regulations.

Indefinite period of time within the terms of employment is considered if employee was employed by the tax payer for at minimum of nine months within the tax period and resided in the area of special state concern or in the area of City of Vukovar.

The manner of tax relief realization is determined according the Regulation on Manner of Business Activity Tax Reliefs Realization in the area of special state concern based on the valid Act.

(Ordinance on the manner of tax relief realizing for the conduction of activity in the area of city of Vukovar and areas of special state concern OG 157/14)

(Act on Income Tax OG 115/16)

(Ordinance on Income Tax OG 10/17, 128/17)

Under the Article 28.a of the Act on Profit Tax and under the Article 55. Of the Act on Income Tax, tax relives for tax payers who perform independent activities are regulated.

Tax payers who perform activities in the areas of local self-government units classified in the first and second group according the development index and in the area of Vukovar city have the right on tax relief on profit tax i.e. income tax.

Certificates on the right to tax relief in a sense of state de minimis support, upon previous request, are issued by the Ministry of Regional Development and European Union Funds.

The book on Regulations on the manner of achieving the tax relief for performing activities in the area of city of Vukovar and aided areas determines that profit tax payers are obligated to submit the request on state de minimis support grant until 15<sup>th</sup> of March of the current year to the Ministry of Regional Development and European Union Funds. Income tax payers are obliged to submit the request on state de minimis support grant until the 28<sup>th</sup> of February of the current year for the previous year. The request is submitted in the form POOD-PPGV.



#### OUT OF THE ACT ON REGIONAL DEVELOPMENT

The policy of regional development means complete and coordinated collection of goals, priorities, measures and activities focused on encouragement of economic growth and overall increase of quality of life, according the principles of sustainable development focused on the long term decrease of regional differences.

The goal of regional development policy is contribution towards social and economic development of the Republic of Croatia, in accordance with the principles of sustainable development, by creation of conditions which will provide strengthening of competitiveness and realization of own development potentials to all parts of the country.

Act on Regional Development (<u>OG 147/14</u>, <u>123/17</u>) focuses on goals and principles of the management of regional development of the Republic of Croatia, methodical documents of regional development policy, bodies authorized for regional development management, assessment of local and regional self-government units development level, the manner of establishing urban areas and areas of special state concern, encouraging of areas of special state concern development, implementation, monitoring and reporting on implementation of regional development policy for the purpose of efficient as possible EU funds exploitation. Development of areas of special state concern ensures support to all areas with social and economic development difficulties for increase and optimum usage of their development potential.

The main goal is contribution to more evenly regional development by assisting areas of special state concern to achieve faster social and economic development and that way decrease the underdevelopment compared to other parts of the Republic of Croatia.

# Evaluation and classification of local and self-government units based on the level of development

Evaluation of level of local and regional self-government units development is based on the development index

Indicators for the calculation of development index, the calculation of development index value, the share of each indicator in overall value of development index is determined by the Regulation of the Government of the Republic of Croatia. The procedure of evaluation of development level of local and regional self-government unit is conducted by the Ministry authorized for regional development sector based on the development index. The evaluation of development level is conducted every three years.

Development index is calculated based on the following indicators:

- Unemployment rate,
- Income per resident,
- Budget revenues of local and regional self-government units per resident,
- General demographic trends,
- · Education rates,
- Aging index



Local (regional) self-government units are classified according the development index into four groups, depending on the value of development index in relation to Croatia's average. The classification of local (regional) self-government units according the development level is conducted every three years according the evaluation.

Likewise, local self-government units are classified according the development index into eight groups and the classification is conducted every three years.

#### **AIDED AREA**

Aided areas of the Republic of Croatia are areas which are based on the development index, evaluated as underdeveloped in relation to national average and its development needs to be additionally encouraged.

Aided areas are defined in the level of local (regional) self-government units.

The aided area status can get:

- · Local (regional) self-government unit classified as the first or second group
- Local self-government unit classified as the first or the first, second, third or fourth group

The Decision on Cassification of Llocal and Regional Self-government Units according the development index (<u>OG 158/13</u>, <u>OG 132/17</u>) is adopted by the Government of the Republic of Croatia under the proposal of the Ministry, based on the development index.

The Ministry is continuously monitoring the level of development of local and regional self-government units.

According the Law special state concern area are all the area that have development index under the average of the Republic of Croatia i.e. first and forth group of local self-government units and first and second group of regional self-government units.



### LOCATION COMPETITIVENESS OF KARLOVAC COUNTY

The decision on capital investment in specific economic sector in specific national and regional territory is based, among other, on expenses that are defined by decisions of national and local government and are very important for the calculation of capital investment profitability.

The term of local competitiveness signifies expenses and potential effects that specific business environment provides to interested investor, and is defined by all the expenses and benefits that are provided on certain administrative area and by the competence of the work force, by the level of development of traffic and energy infrastructure and other.

Besides the mentioned, the attractiveness of the location is also affected by the so called friendly environment of the local community, that is the overall impression that the entrepreneur is welcome and the local government and institutions are doing everything within its possibilities to provide faster and more quality realization of the investor's initiative. In other words, entrepreneur is being approached as partner in accomplishing the joint goal - the increase of number of employees, the increase of economic activity of the region and to achieve higher level of local community prosperity.

The educational infrastructure which includes the network of secondary schools, private educational institutions and the University represents powerful potential that can crucially affect development possibilities of the region. Modern economy which is based on knowledge uses with good reason the phrase "the industry of education", where the word industry refers to the model of education which follows contemporary trends on all levels, formally and informally, full time and part-time, and offers the most recent technical, marketing and other information to the entrepreneurs in order to strengthen the ability of its staff potential.

Encouraged by numerous inquiries of potential investors, in this material we present named expenses with the intention of emphasis of benefits that are offered in the Kalovac County to the investor.

Expenses and price lists valid just before the publishing of this material are presented and are as such submissive to changes.

One more very important remark – projects that are extremely important for the development of the local community and the County, definitely deserve special approach so such projects can become the subject of special agreement with the investor.



#### 1. STAFF COSTS

#### 1.1. Employee's salary

Employer is obliged to calculate and pay a salary, no later than fifteenth day of the month for the previous month, unless is otherwise determined by the collective agreement or employment contract.

At the payment of salaries, all statutory contributions, as well as income tax and local income tax must be simultaneously calculated and paid. Salary mustn't be paid in cash.

Salary is being paid in the amount determined by the collective agreement, employment ordinance, and employment contract.

The employer cannot pay salary amount lower than the minimum wage amount which is being determined by the Government of the Republic of Croatia through the Regulation based on the Minimum Wage Act, and full time salary is determined for the period from 1<sup>st</sup> of January till the 31<sup>st</sup> of December 2018 in the gross amount of 3.439,80 HRK per month (OG 122/2017).

Gross salary amount is being increased for every completed year of service by 0,5 percentage points.

The employer is obliged to calculate and pay 20,00% of contributions of the gross salary:

- 15% retirement contribution pillar I (generational solidarity)
- 5% retirement contribution pillar II (individual capitalized savings)

The employer is also obliged to calculate and pay 17,20% contributions on the gross salary:

- 15% health insurance contribution
- 0,5% occupational health contribution
- 1,7% employment contribution

The employee is obliged to pay personal income tax and local income tax, depending on the amount of monthly income after deduction of contribution and personal deduction, i.e. the minimum of 3.800,00 HRK per month, and is increased depending of the number of children and other dependant family members and level of invalidity. Calculated income tax is reduced by 50% for persons who have residence in the assisted area in the 1<sup>st</sup> group considering the development level.



In accordance to The Act on Income Tax (OG 115/2016), income tax is paid as follows:

- 24% on monthly tax base up to 17.500,00 HRK,
- 40% on monthly tax base over 17.500,00 HRK.

The local income tax rate is being determined by Decision of towns and municipalities:

Ozalj: 10%
Slunj: 5%

#### 2. ELECTRICITY PRICES

According to the <u>Energy Act</u>, the Government of the Republic of Croatia has established the tariff system for the service of electric power activities which are performed as public services for different energy consumers, i.e. different types of buyers, depending on the type, power and other elements of the delivered energy.

The connection fee for all groups of consumers is defined by the Decision on the connection price.

Depending on the demanded power, consumers pay the price of 1 kW = 1.350,00 HRK + VAT.

Where there is no infrastructure constructed, actual expenses of transformer substation construction are added at indicative prices:

•	Transformer substation	630 kWh	50.000 EUR

<u>ELECTRIC – POWER INDUSTRY KARLOVAC</u> applies prices based on <u>four tariffs for entrepreneurs</u>. Cost for entrepreneur is determined and invoiced per month, enlarged for the monthly fee in the amount of 65,00 HRK up to 106,00 HRK.

According to the <u>Act on Electricity Market</u>, company HEP Operator of distribution system has two functions towards the end users:

- The first one, it is the only energy entity authorized to provide public services of electricity supply in the Republic of Croatia, which means that the HEP Operator of distribution system obligation is to provide public service of electricity supply, in a regulated manner and at a regulated price;
- The second one, it is energy entity which performs activities related to electricity distribution, concludes contracts on use of network with customers who are connected to the distribution network and performs the calculation of the fees for network use.

The following are entitled to calculation of electricity according to tariff items for tariff customers in the public service:

- All categories of household customers,
- Other eligible customers whose provider has ceased to operate, but only for a period of 30 days.

After the 30 days expiration, eligible customers who haven't found another supplier pay the consumed electricity at a cost of balancing energy. Such customers have to conclude a contract with HEP distribution system operator on energy supply service to the eligible customers at a cost of balancing energy.

The tariffs under which HEP distribution system operator performs the calculation on consumed electricity are being published in the Official Journal of the Croatian Republic – Official Gazette. Simplified and unified overview of tariff items according to the activities is shown in the following tables:



#### **Tariff rates (prices)**

Tariff rates for commercial customers are applicable according the Methodology for Determination of Amount of Tariff Rates for Electricity Distribution (OG 104/15), Decision on the Amount of Tariff Rates for Electricity Distribution (OG 134/15), Methodology for Determination of Amounts of Tariff Rates for Electricity Transmission (OG 104/15) and Decision on the Amount of Tariff Rates for Electricity Transmission (OG 134/15).

#### **Tariff models**

Tariff models that are available for commercial customers depend on voltage level which the network user is connected and the type of counter that is installed.

For commercial customers connected to network of medium, high and very high voltage tariff model White is determined that contains tariff rates for following tariff elements:

- active energy according the higher diurnal tariff (HRK/kWh)
- active energy according the lower diurnal tariff (HRK/kWh)
- billing peak reactive power (HRK/kWh)
- excess reactive energy (HRK/kvarh) and
- charge for metering service and supply (HRK/month)



For commercial customers connected to network of low voltage tariff models Blue, White, Red and Yellow are determined.

#### **Tariff model Blue** contains tariff rates for following tariff elements:

- active energy according the unique diurnal tariff (HRK/kWh)
- excess reactive energy (HRK/kvarh) and
- charge for metering service and supply (HRK/month)

#### **Tariff model White** contains tariff rates for following tariff elements:

- active energy according the higher diurnal tariff (HRK/kWh),
- active energy according the lower diurnal tariff (HRK/kWh),
- excess reactive energy (HRK/kvarh) and
- charge for metering service and supply (HRK/month)

**Tariff model Red** refers to commercial customers with the connection power over 20kW and contains tariff rates for the following tariff elements:

- active energy according the higher diurnal tariff (HRK/kWh)
- active energy according the lower diurnal tariff (HRK/kWh)
- billing peak reactive power (HRK/kWh)
- excess reactive energy (HRK/kvarh) and
- charge for metering service and supply (HRK/month)

#### **Tariff model Yellow** (public lighting) contains tariff rates for the following tariff elements:

- active energy according the unique diurnal tariff (HRK/kWh),
- charge for metering service and supply (HRK/month).



#### 3. PRICE OF TELEPHONE SERVICES

There are six telecommunication operators in the field of fixed and mobile telecommunication in the Republic of Croatia. Connection fees to the telephone network and the monthly subscription fee depends on the operator and the model of subscription. Some operators provide fixed network services, some provide mobile services and some provide both fixed and mobile.

#### 4. LOCAL EXPENSES OF KARLOVAC COUNTY

#### 4.1. The municipal contribution and Utility service fee

It is paid by owners for the construction or upgrading of construction structures per m<sup>3</sup> of the planned area. Contributions are determined according to zones, groups of activities and equipment.

#### Utility service fee

Funds for the financing of municipal activities are acquired by utility service fee paid by legal entities and natural entities in a particular town or municipality.

This refers to drainage of atmospheric waters, maintenance and cleaning of public surfaces, maintenance of non-classified roads, cemetery maintenance service etc.

Utility service fee is in general paid in settlements with developed construction land, by owners of the residential and business premises, and owners of construction land. This means that settlements must have the following access road, facilities for electric power supply and water supply.



Financial assets collected throughout utility service charge are revenues of a town or municipality budget.

Municipal activities, such as thermal energy supply, public passenger transport, waste disposal and the removal of municipal waste, retail markets, funeral services and chimney-sweeping activities are funded by the public utility service payment.

The property owner is obliged to pay these public utility services to the service provider.

The amount of utility service fee is determined by a town or municipality authority based on the level of development of construction land, facility zone location, intended use of the facility i.e. business premises.

Utility service fees are paid per commercial area unit of residential or business premises, i.e. surface area of construction land.

#### 4.2. Water, drainage and thermal energy costs

Water costs for business entities are determined by the availability of water resources and the technology of cooling process, cleaning and washing.

The price of water supply and drainage comprises several elements. The basic price comprises all processing costs, and the price is determined by the municipal company with the consent of the owner i.e. municipal bodies or town administration.

Water protection (drainage) fees are paid according to the total amount of waste water or according to the level of contamination or other changes to water, as defined by the Decision on Water Protection Fees.

#### 4.3. Natural gas supply

#### 5. CONTRIBUTIONS, DUES AND FEES

Membership fees, contribution fees and dues are generally paid in advance during the calendar year determined in monthly or quarterly sums which are based on the final account for the previous year, and the annual dues had to be determined according to the annual balance sheet, and pay the difference or determine the amount to be returned or included in paid obligations for the next billing period.

#### 5.1. Forests fee

According to the <u>Act on forests</u>, with the aim of preservation of biological diversity of forests and management based on economic and ecologic sustainability, fees are determined as follows:

#### 5.2. Due to the Croatian Chamber of Economy

The members of the <u>Croatian Chamber of Economy</u> are all legal and natural entities that perform business activities and have their headquarters in the Republic of Croatia. Legal entities become members of the Croatian Chamber of Economy by their registration in the Register of Trades, and natural entities become members through their associations.

Legal entities – members of the Croatian Chamber of Economy are obliged to pay membership fees monthly according the CCE Decision. The amount of membership fee in 2017 is defined by following criteria:

Classification is based on data gathered out of annual financial reports of entrepreneurs for the previous year.



CCE members which are founded and registered in Court Register after January 1<sup>st</sup> 2018 are exempt from membership payment in the period of one year from the day of registration. Volunteer membership can be relized by signing the application form and by annual membership fee payment in the amount determined for the first group of criteria.

#### 5.3. Contributions to the Croatian Chamber of Trades and Crafts

Craftsman, merchants who perform trade according the Act on Trades, natural entities, trading companies and other legal entities which are a voluntary members of the <a href="Croatian Chamber of Trades and Crafts">Croatian Chamber of Trades and Crafts</a> are obliged to pay the Contribution to the Croatian Chamber of Trades and Crafts.

The amount of Chamber's contribution is prescribed in the amount of 2% of the amount of basic personal deduction according the Act on Income Tax, i.e. 76,00 HRK per month for 2018. Newly registered crafts are exempt from Chamber's contribution payment in the first year of business.

#### 5.4. Fees for concession for exploitation of mineral resources

The parties obliged to pay the fee for mineral resources exploitation are legal entities – trading companies and natural entities – craftsmen who exploit mineral resources based on license or mining concession issued by the Ministry of economy i.e. State administration office in the local (regional) district responsible for mining activities according to <u>Act on Mining</u>.

The amount of minimum <u>annual concession</u> fee is defined by the Regulation of the Government of the Republic of Croatia, proposed by the ministry in charge of mining.

#### 5.5. Tourist Boards Membership Fees

The parties obliged to pay the Tourist Board membership fees are legal and natural entities who have their headquarters or business establishment which continuously or seasonally generate revenue in providing of catering and tourist services as well as performing activities directly related to tourism.

The amount of membership fee depends on tourist category of the settlement where headquarter or business establishment is situated, the type of activity (according to NCA 2007), and the rate level. The basis for payment is total revenue generated in the tourist destination, and is paid monthly in advance according to the calculation of business outcome for the previous year.

#### **5.6. Monument Annuity**

Natural and legal entities who perform business activities in stationary culture asset or in the area of cultural heritage complex are obliged to pay direct monument annuity. The amount of direct monument annuity is defined by the Decision of a town or a municipality, and varies from one to four HRK per square meter of useful business area surface which is situated in stationary cultural asset or in the area of cultural and historic unit.

The obligators of indirect monument annuity are natural and legal entities who perform the following activities according to NCA: 46.22, 46.34, 46.35, 46.37, 46.39, 46.45, 46.46, 46.48, 49.32, 51.21, 52.22, 52.23, 55.10, 56.30, 61, 64.1, 66.1, 66.1, 77.11, 77.21, 77.34, 79, 92.00, 93.19, 93.21, 46.35, 46.45, 47.26, 61, 64.1, 66.1, 92.00

Indirect monument annuity is paid at the rate of 0,05%, and the calculation base is overall revenue generated by performing activities named above.



#### 6. TAXES, SPECIAL TAXES AND EXCIES DUTIES

Croatian tax system is compatible to European principles which equalize all tax payers, i.e. domestic and foreign natural and legal entities. Croatian tax system has many tax forms which can be found on web site (<a href="www.porezna-uprava.hr">www.porezna-uprava.hr</a>) along with the list of tax payers, tax bases, tax rates and associated Acts and Ordinances.

#### 6.1. Value added tax

Value added tax payer is every person who performs any kind of independent business activity regardless the purpose and the result of the business activity. The one who has no headquater, business unit, resident or temporary resident within the Republic of Croatia but performs inland deliveries of goods or services of which taxation takes place in the Repuplic of Croatia is also tax payer. Taxation target is the delivery of goods and providing services with payment in the country performed by tax payer, acquisition of goods with payment inside the EU as well as import of goods.

Three VAT rates are applied in the Republic of Croatia:

- 25% general rate;
   13% accommodation services with breakfast, half board or full board in hotels or similar facilities, property rental in camps, accommodation in floating facilities of nautical tourism; newspapers and magazines issued by newspaper publisher periodically; eatable oils and fats of vegetable and animal origin; children car seats; children foods: delivery of water; concert tickets; electricity delivery; public service of municipal waste collection; urns and coffins; plants and seeds:
- 5% all sorts of bread and milk: professional, scientific, cultural and educational books; textbooks for pedagogic education and primary, secondary and faculty education; prescribed medicines; medical equipment and orthopedic devices; cinema tickets: newspaper published by newspaper publisher who has a status of media, printed on paper, published daily; scientific magazines;

fertilizers and pesticides: animal food excluding pet food;

#### 6.2. Profit tax

Profit tax payers are natural entities who perform business activities and have profit according to regulations on profit taxing if they declare to pay profit tax instead of income tax or if they are obligated due to the amount of business activities they perform. That is, if total icome of 3.000.000,00 HRK is generated for the previous period or if two out of following three criteria are fulfilled: over 400.00,00 HRK of generated income; over 2.000.000,00 HRK in assets; employs over 15 employees within the previous tax period.

Tax base is the profit determined by accounting regulations and represents the difference between income and expenditure before income tax calculation, enlarged and decreased according the Act on Profit Tax regulations.



Profit tax is being payed on determined tax base by rate of:

- 1. 12% if income up to 3.000.000,00 HRK is realised within the tax period, or
- 2. 18% if income equal or over 3.000.000,01 HRK is realised within the tax period.

#### 6.3. Income tax

Income tax payer is natural person who has income form employment, from selfemployment, from assets and property rights, income from capital, from insurance and other income.

Resident income tax base represents the overall amount of income realized inland and abroad (the principle of world income), but decreased by 3.800,00 HRK of personal deduction per month.

Two tax rates are applied for income tax calculation, depending on the amount of tax base (24% and 36%) as described in chapter Staff costs. Local income tax is calculated on the amount of income tax if it is prescribed for the municipality or the town in which the tax payer has its residence.

Income made inland and abroad are subjects to taxation for residents, and only income made abroad for non residents.

#### 6.4. Consumption tax

Every legal and natural entity who provides catering services is obliged to pay consumption tax. Tax is paid for consumption of alcohol drinks (brandy, schnapps and strong drinks), natural wines, special wines, beer and non-alcohol drinks in catering facilities.

Tax is calculated on selling price of drink without Value Added Tax added, and tax rate is defined by town or municipality, up to 3%.

#### 6.5. Tax on the use of public areas

Tax on the use of public areas is paid by all legal and natural entities who use public areas under conditions defined by the municipality or the town. The definition of public area, the amount of tax and payment proedure is determined by the municipality or the town.

#### 6.6. Property transfer tax

The property acquirer is obliged to pay the property transfer tax, and the tax base is property value at the moment of acquisition. Property transfer tax rate is 4%.

Acquisition of property on which VAT is paid is not hereby considered property transfer. If tax payer who is entered in the register of taxpayers delivers construction land and/or constructed property which has not been used at all or under two years, VAT at the rate of 25% will be calculated upon the property delivery.

#### 6.7. Holiday house tax

All legal and natural entities who are the owners of holiday houses pay the holiday house tax. The amount of tax is determined by the decision of towns or municipalities depending on the placement, age, condition of the infrastructure as well as other significant circumstances relevant for the use of holiday house, in the annual amount of 5,00 to 15,00 HRK per square meter of useful area.



# 6.8. Tax on profit out of games on chance and contribution for organization of games on chance

Natural entities who gain profit out of games on chance pay the tax on profit out of games on chance. Tax base for the calculation is the amount of single profit or market value of items, services or rights which make single profit, and is paid at the rate of 10 to 30%.

The organizer of games on chance pays the monthly amount of 10% of base i.e. overall amount of sold lottery tickets with all forms of lottery, i.e. the overall amount of received payments for single game. The Act on Games on Chance defines obligations of organizer of games in casinos, betting games and games on chance on machines. Organizers of games on chance are obliged to pay the fee in the amount of 5% of determined value of fund of prize games in the favour of The Croatian Red Cross.

#### 6.9. Tax on road motor vehicles

Tax on road motor vehicles is paid by legal and natural entities who possess registered automobiles and motorcycles (up to 10 years of age). Tax is paid annually within the registration or certification of prolongation of registration card validation according the motor power in KW and the age of vehicle, from 200,00 HRK to 1.500,00 HRK for automobiles, from 50,00 HRK to 1.200,00 HRK for motorcycles and from 30,00 HRK to 120,00 HRK for four-wheelers.

#### 6.10. Tax on vessels

Legal and natural entities who possess registered vessels are obliged to pay tax on vessels. Tax is paid annually according the Decision of responsible tax authority of the area where the vessel is registered. The amount of tax depends on the length of the vessel in meters, motor power in kW as well as whether the vessel has the cabin or is sail driven. The tax amount for vessel without the cabin varies from 100,00 HRK to 600,00 HRK, for motor driven vessel with cabin from 200,00 HRK to 5.000,00 HRK and sail driven vessel with cabin from 200,00 HRK to 4.000,00 HRK.

#### 6.11. Special tax on motor vehicles

The subject of taxation are all personal automobiles and other motor vehicles constructed primarily for person transportation, included caravans, vans, racing cars, motorcycles, mopeds, bicycles and similar vehicles with or without side trailer, pick-up vehicles with double cabin, ATV vehicles, other motor vehicles converted into named vehicles for which special tax hasn't been calculated and paid in the Republic of Croatia.

Tax payer is every natural or legal entity, the buyer of the vehicle.

Special tax on new vehicles is determined on base of Carbon dioxide emission (CO2) expressed in grams per kilometre, selling price of motor vehicle, motor power in kilowatts, engine volume in cubic centimetres and emission of exhaust gas. Special tax on used vehicles is paid in the amount of the rest of special tax determined on the percentage of decrease of value of the same motor vehicle on the market in the Republic of Croatia for which the same time period has passed since the first registration.



#### 6.12. Special tax on coffee and non-alcoholic beverages

The subject of taxation are coffee (roasted coffee, extracts, essences, coffee drinks, substitutes and non-alcoholic beverages which contain coffee) and non-alcoholic beverages (water, including mineral, carbonated and with added sugar, other beverages with share of alcohol up to 1,2%, syrups, concentrates, powders and granules) which are placed on market of the Republic of Croatia.

Tax base for coffee taxing is one kilogram of netto weight. Special tax is paid on roasted coffee and roasted coffee in final product in the amount of 6,00 HRK/kg i.e. 20,00 HRK/kg for extracts, essences and coffee concentrate.

Tax base for non-alcoholic beverages taxing is one hectoliter. Special tax is p0aid in the amount of 40,00 HRK/hl for water and other beverages with alcohol volume up to 1,2%, 240 HRK/hl for syrup and concentrate and 400,00 HRK/100kg of net weight for powders and granules.

#### 6.13. Tax on premiums on automobile liability insurance and premiums on allrisk insurance of motor vehicles

Tax payers are insurance companies which enter into agreement with legal and natural entities and charge premiums on automobile liability insurance and all-risk insurances of motor vehicles directly or indirectly through agents or representatives.

Tax base is insurance premium which is determined by insurance company at contract conclusion, and tax rate is 15% of agreed premium of automobile liability insurance, i.e. 10% of agreed premium of all-risk insurance of motor vehicles.

#### **EXCISE DUTY**

Croatian excise duties system is regulated by the <u>Act on Excise Duties</u> which determines taxing of alcohol and alcohol beverages, tobacco products, energy-generating products and electricity. Besides these products, other products for example coffee, non-alcoholic beverages and motor vehicles are also assessed.

#### 6.14. Excise duty on alcohol and alcohol beverages

Beer, wine other beverages produced by fermentation besides beer and wine, semiproducts ad ethyl alcohol are considered alcohol and alcohol beverages. Still and sparkling wines are considered wines.

Excise duty is paid in the amount of 40,00 HRK for 1% volume of pure alcohol in one hectoliter of final product.

Excise duty on semi-products with 15% volume of pure alcohol is paid in the amount of 800,00 HRK per hectoliter of final product. Excise duty on semi-products with less than 15% volume of pure alcohol is paid in the amount of 500,00 HRK per hectoliter of final product.

Excise duty on ethyl alcohol is paid in the amount of 5.300,00 HRK per hectoliter of pure alcohol. Excise duty on still and sparkling wines and other drinks produced by fermentation, except beer and wine is not paid.

Excise duty on small independent breweries is within the amount of 20,00 HRK and 26,00 HRK per hectolitre depending on annual volume produced.



#### 6.15. Excise duty on tobacco products

Cigarettes, cigars, cigarillos and tobacco for smoking are considered tobacco products..

Excise duty on cigarettes is paid in the form of special excise duty in determined amount for 1.000 pieces of cigarettes and in the form of proportional excise duty prescribed in certain percentage of cigarette retail price. Specific excise duty on cigarettes is 310,00 HRK for 1000 pieces of cigarettes and proportional excise duty in the amount of 34% of retail price. Minimum excise duty on cigarettes is 696,00 HRK for 1000 pieces of cigarettes and is paid if the amount of overall calculated excise duty is lower than prescribed.

Excise duty for fine-cut tobacco for cigarettes folding and for other types of smoking tobacco is 600,00 HRK per one kilogram.

#### 6.16. Excise duties on energy products and electricity

The subject of taxation are energy products used for motor fuel or heating fuel as well as electricity. Petroleum products and biofuels, solid fuels (carbon and coke), natural gas and all of the other products if used for drive of motor vehicles or heating are considered energy products.

Excise duty base for energy products is 1000 kilograms of mass, 1000 litres at basic conditions of temperature of energy product of +15 degrees °C, GJ gross heat value. Excise duty base for electricity and natural gas is the amount of electricity, i.e. natural gas measured in MWh.

- For motor petrol used as motor fuels: leaded petrol 4.500,00 HRK/1000 I, and leaded-free petrol 3.860,00 HRK/1000 I
- For gas oil: 3.060,00 HRK/1000 I for drive, i.e. 423,00 HRK/1000 I for heating
- For kerosene-petroleum: 2.660,00 HRK/1000 I for drive, i.e. 1.752 HRK/1000 I for heating
- For LPG liquid gas: 100,00 HRK/1000 kg for drive and heating
- For hard fuel oil: 160,00 HRK/ 1000 kg
- For natural gas: 0,00 HRK / MWh for drive, 4,05 HRK / MWh for business use and 8,10 HRK / MWh for non-business use
- For carbon and coke: 2.30 HRK /GJ for business and non-business use
- For electricity: 3,75 HRK / MWh for business use and 7,50 HRK / MWh for nonbusiness use
- For biofuels: 0,00 HRK

All legal and natural entities who conducts business using excise duty products is obliged to register in the Register of excise duty payers in customs office under whose jurisdiction the residence is situated.
