When the original carnet expires and a replacement carnet needs to be processed, if the goods are located in Latvia, this procedure can take place in Latvia even if the initial importation was made in another EU member state. The replacement carnet must be presented to the customs together with the original carnet. Customs may ask the holder (or representative) to present the goods.
- Additional observations (if any):
  It is recommended to replace the carnet at the customs office of the Republic of Latvia, where the original carnet was accepted.
