Replacement carnet

Yes, in accordance with Article 14, Annex A of the Istanbul Convention. A replacement Carnet must be applied before the expiry of the original Carnet.

Example: the validity date of the Carnet is 01.10.2015, the Carnet holder can apply for a replacement Carnet until 30.09.2015.

Regularization fee requested by Customs

In Türkiye, the engagement of a customs broker is not mandatory; however, carnet holders may, at their discretion, seek the services of a customs broker.

Determined according to the **2026 Minimum Fee Tariff for Customs Brokerage and Authorized Customs Brokerage** published in the Official Gazette No. 33123 dated 30 December 2025.

Fees apply to inspection operations (GC1 and GC2) carried out by Authorized Customs Brokers as per the Temporary Import Regime.

Special observations

1.Special conditions concerning the operation of the ATA System in Türkiye

Carnet holders are **required to complete** the electronic declaration in the Turkish ATA Carnet registration system **prior to presenting the goods to Customs, both upon entry into and exit from Türkiye.**

If not completed in advance (before arriving Custom Office), customs officers will fill in the declarations at the border where required, BUT, which may take additional time.

Note: Ministry of Trade of Türkiye has introduced a new password-based login procedure for obligors/users accessing the registration system. As of 30 April 2026, users who wish to access the registration system are required to complete the following steps:

- 1) **Apply in person at Turkish Customs:** Users must apply directly to Turkish Customs in order to obtain their initial password.
- 2) **Contact authorized customs personnel:** The application should be made to either:
 - the **contact service desk** at the customs office, or
 - customs personnel authorized as an **inspection officer**.
- 3) **Submit required user information (one-time registration):** For the initial registration, users must provide:

User identification information to be used for system login:

- National ID number, or Tax number, or Passport number, and
 - E-mail address
- 4) **Password delivery:** After registration, the system will automatically send the password to the e-mail address provided by the user.
 - 5) **Login to the system:** Users may log in to the e-ATA/TR system using:
 - the registered user information (ID/Tax/Passport number), and
 - the password received by e-mail.
 - 6) **Password change:** After the first login, users may change their password directly within the application.

2. Use of Carnets by representatives

If a representative (e.g., driver) handles customs formalities, the registration must be completed with the representative's own details.

The representative must be listed in the ATA Carnet's representative section.

If a representative is not clearly indicated in Box "B", the attached Power of Attorney must be submitted together with the ATA Carnet as filled and signed/stamped by the carnet holder and signed and sealed by the Issuing Chamber **or** Embassy/Consulate **or** Notary. It is advised to use the standardised template of the Power of Attorney,

3. Temporary admission with partial relief from duties and taxes

Turkish Customs charge **3% of total duties monthly** for goods temporarily imported with partial relief.

4. Extension of the temporary admission period

Extensions may be granted by Turkish Customs up to the **validity date of the Carnet**.

5. Penalties in case of violation of temporary importation provisions

- According to Article 238(1)(a) of the Turkish Customs Law (No. 4458), in case of violations of the provisions of the temporary import regime, an administrative fine of **twice the customs value of the goods** will be imposed.
- Under Article 238(1)(d), if goods imported under the temporary import regime are not subjected to a Customs-approved procedure or use within the allowed period, an administrative fine will be imposed **together with interest calculated at the rate determined under Law No. 6183** for the period from the registration of the declaration to the date of inspection.
- Under Article 238(2)(d), if the goods are not subjected to a Customs-approved procedure or use **within 60 days from the date of notification, an additional administrative fine equal to the amount of customs duties** will be applied

Irregularity Penalties

- Pursuant to Article 241(3)(l), if goods brought into the Customs Territory of Türkiye under the temporary import regime are re-exported or subjected to a Customs-approved treatment or use **within one month following the expiry of the authorized period**, an administrative fine equal to **twice the irregularity penalty** stipulated under Article 241(1) shall be imposed (1,494 TRY for 2026, subject to annual adjustment).
- Under Article 241(3)(m), if goods imported under the temporary import regime are taken out of the Customs Territory of Türkiye within the authorized period **without notifying Customs**, but this is proven by acceptable documentation, an administrative fine equal to **twice the irregularity penalty** shall be imposed.
- According to Article 241(4)(g), if re-exportation or Customs-approved treatment/use takes place **within two months following the expiry of the authorized period**, an administrative fine equal to **four times the irregularity penalty** shall be imposed.

If no valid proof is provided, duties and taxes will be charged via NGA, and penalties beyond NGAs' liability will be charged directly to the holder.

6. General list required on a spreadsheet

Turkish Customs requires all general lists digitally.

Holders are advised to save their Carnet general lists as Excel files on a USB stick and provide them upon request

7. Country name change

Türkiye has officially changed its name.

Existing Carnets remain valid; new Carnets must indicate "Türkiye" in Box P.

Pre-printed forms: cross out "Turkey" and manually write "Türkiye."
